Looking to the future

The idea of forward planning for our death is far from our minds when we are healthy and leading full lives. Most of us don't think about death until there is a threat, either to ourselves or to those we love.

Nobody knows when they will die but it will happen either expectedly or suddenly. So often people die without giving any guidance as to their wishes, so that those left behind are left wondering what the deceased would have liked.

Making a will is an important step forward. It gives mourners an opportunity to carry out your wishes at a time when they are grieving, when making decisions can be difficult.

A solicitor can guide you in writing a will, or you may prefer to buy a plan and do it yourself.

You may want to suggest a funeral director to take your funeral. Do you want a religious service taken by a priest or a non-religious service led by a celebrant? What music and readings would you choose?

Would you prefer burial or cremation? If cremation, would you like your ashes released in a special place? Do you want a head stone?

You may want to leave specific items/money to different people. If there is no will, it may be difficult for family and friends, so that tensions can arise. If people die without a will, gaining probate can take many months.

You may want to know about lasting power of attorney, living wills, or pre-paid funeral plans.

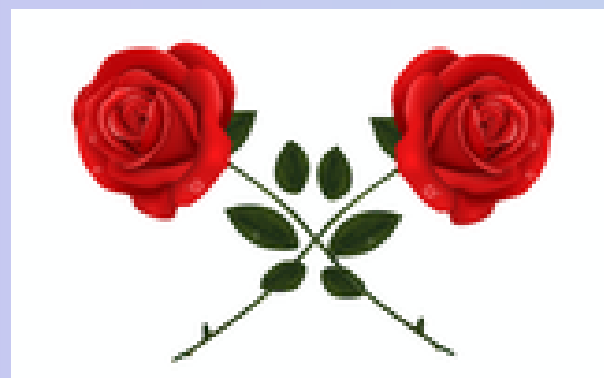

Lasting Power of Attorney

It is worth contacting a solicitor to talk this through, in case you are unable to make your own decisions in the future about financial affairs and/or health and social care.

Future Treatment and Care
